SPF 101

SPF stands for Sun Protection Factor. It is the global standard measurement of a product's ability to protect against UVB rays. The number that follows the SPF, such as SPF 30 or SPF 50, refers to how long the product will protect the skin before application is required. So you can think of a product marked SPF 50 as a product that protects skin 50X longer than bare skin alone, on average.

Chemical vs. mineral sunscreen

Chemical sunscreens work like a sponge, absorbing the sun's rays. They contain one or more of the following active ingredients: oxybenzone, avobenzone, octisalate, octocrylene, homosalate, and octinoxate. These formulations are easier to rub into the skin without leaving a white cast.

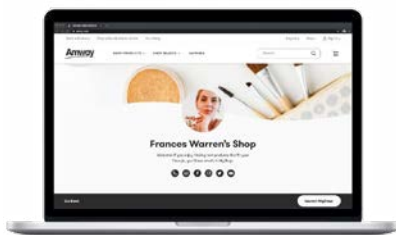

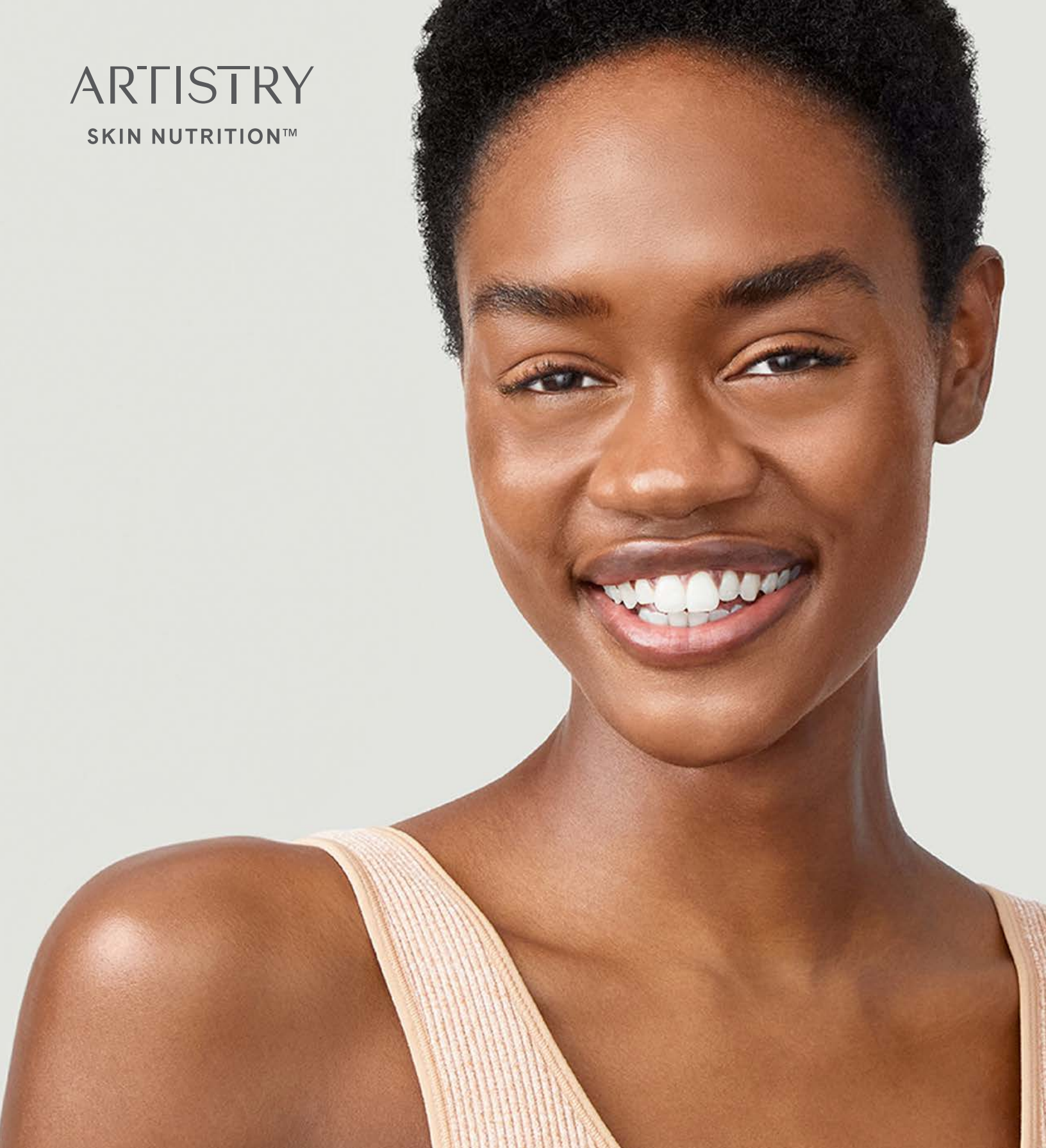
